Brooke's Place is the only ongoing grief support program in Central Indiana for families with children between the ages of 3 and young adult who have experienced the death of someone significant. During 2018, Brooke's Place served a total of 841 individuals in support group programming.

4b (Code:) (Expenses \$ **159,123** including grants of \$) (Revenue \$ **111,093**)

Therapy Services: Brooke's Place provides individual therapy services to children ages 3 and over through young adult, using licensed mental health counselors. The therapy for children is based on play therapy, and empowers participants to feel supported and understood. In addition, there were 274 individuals who received 1,752 completed counseling sessions and professional grief support.

BP-8 Outreach Program: An 8-week outreach grief support group program that allows Brooke's Place to partner with community organizations, churches, schools, and after-school centers to reach underserved youth needing grief services. With 145 individuals served, 2018 saw a 77% increase in numbers served over 2017.
