Brooke's Place is the only ongoing grief support program in Central Indiana for families with children between the ages of 3 and young adult who have experienced the death of someone significant. During 2019, Brooke's Place served a total of 890 individuals in support group programming.

BP-8 Outreach Program: An 8-week outreach grief support group program that allows Brooke's Place to partner with community organizations, churches, schools, and after-school centers to reach underserved youth needing grief services. In 2019, 108 individuals were served at 11 community partner sites.

Therapy Services: Brooke's Place provides individual therapy services to children ages 3 and over through young adult, using licensed mental health counselors. The therapy for children is based on play therapy, and empowers participants to feel supported and understood. In addition, there were 301 individuals who received 1,859 completed counseling sessions and professional grief support.
